40 **II. DEFINITIONS OF CLASSROOM CONTACT HOURS**

41  
42 The purpose of the meeting today is for the Board to determine whether online continuing  
43 education can be accepted when the Chiropractic Medicine Practice Act is specific to the phrase  
44 "contact classroom hours."

45  
46 **a. Possible Options for Definition of Contact Classroom Hours**

48 Currently, the requirement is a live classroom setting in which the students are monitored. But  
49 there are other options. One of them is webinars that are held at a set time and are recorded.  
50 Some examples were given. There were concerns about filtering out all of the courses that could  
51 be submitted to the Board if no exact criteria are set. The Board currently has standards for live  
52 courses. The Board would need to set criteria for online courses if the Board feels it has the  
53 authority to set the type of continuing education that can be allowed.

54  
55 Mr. Harris advised the definition of contact hours could be defined if the number of online  
56 hours are limited and would likely hold up in a rule challenge. The Board can go ahead and  
57 write a rule that allows all 40-hours to be achieved online or just leave it split as it is currently.

58  
59 The Board determined it does have the statutory authority to define the phrase “contact  
60 classroom hours.” The 10-hours of online continuing education has not been determined to be  
61 effective or ineffective. Legal action for limiting online credits was discussed but it is still open  
62 for discussion at a later date.

63  
64 Dr. Weingarten discussed Option C and wanted this section to be discussed later. Section C  
65 creates separate standards for approval of physical attendance and online attendance courses.  
66 Identity authentication was discussed and will be followed-up on. Dr. Hunt spoke about  
67 Activator, a set of coursework she would like the Board to consider when considering a rule  
68 change for online continuing education. Dr. Heagy has not seen a live webinar course for  
69 approval since serving on the Continuing Education Committee.

70  
71 Courses approved under the old rule will stay approved; only new applicants will be subject to  
72 the changes.

73  
74 Public comment was opened. Each discussion was limited to three minutes.

75  
76 **Speaker one:** Dr. Dougherty, a former Florida Board of Chiropractic Medicine member spoke  
77 to follow-up with some previous board business. He was present at the November 3, 2017  
78 Board Meeting as a voting member. Dr. Dougherty addressed the Board and discussed the  
79 Florida Chiropractic Society or the FCS and the Florida Chiropractic Physician Association or  
80 the FCPA. Both Organizations do not favor 100% online continuing education. Dr. Warner did  
81 not appear as he originally claimed to partner with the Florida Chiropractic Society and the  
82 Florida Chiropractic Physician Association.

83  
84 **Speaker two:** Ms. Driggers with the Florida Chiropractic Association addressed the Board on  
85 the legalities of the Board’s current dilemma with continuing education. Ms. Driggers stated her  
86 legal opinion was the phrase contact hours meant face to face. Ms. Driggers used the University  
87 of Bridgeport case to make some points. Ms. Driggers cited Rule 64B2-13.004(3)(h) is in direct  
88 conflict with online continuing education involving a webcast.

89  
90 **Speaker three:** Ms. Champion’s opinion was the Board had the authority to interpret its own  
91 laws and rules. Her opinion was the Board had the ability to define the phrase contact classroom  
92 hours.

94 Public comment was closed at 2:30 p.m.  
95  
96 Dr. Fogarty reemphasized the Board does have the statutory authority for the current online  
97 issue. The current 10-hours does not appear to be going well as originally structured.  
98  
99 **Action:** Motion to allow contact classroom hours that are face to face and virtual but it must be  
100 real-time interaction for the students and for the educators made by Dr. Heagy. No second.  
101  
102 **Action:** Motion to define a contact classroom hour shall mean 1-hour of continuing education  
103 with real time face to face interaction between an instructor and student that occurs in a  
104 classroom type environment made by Dr. Heagy. Second made by Mr. Colter.  
105  
106 Discussion continued. Dr. Fox proposed the concept of pre-recorded continuing education being  
107 accepted.  
108  
109 **Action:** Motion to define classroom contact hours as 1-hour of continuing education in which  
110 real-time face to face interaction between instructor and student occurs in classroom type  
111 environment and add this could also include pre-recorded material with a moderator made by  
112 Dr. Heagy. Second made by Mr. Colter.  
113  
114 **Action:** Mr. Colter withdrew the second after discussion. Amended motion fails.  
115  
116 Discussion ensued about the flexibility required to obtain continuing education credits.  
117  
118 The Board decided to leave the current requirement of only allowing 10-hours of continuing  
119 education attained thru online systems to remain in place. There will be no expansion of this at  
120 this time.  
121  
122 **Action:** Motion to accept Option C as the Board's definition of classroom contact hours made  
123 by Mr. Colter. Second made by Dr. Fox.  
124  
125 When the Board defines contact classroom hours, it applies to all 40 hours, not a portion of  
126 them.  
127  
128 **Vote:** Roll-call:  
129  
130 Dr. Fogarty, No.  
131 Dr. Heagy, No.  
132 Dr. Fox, Yes.  
133 Dr. Weingarten, No.  
134 Mr. Colter, Yes.  
135  
136 **Action:** Motion fails.  
137  
138 The decision to define classroom contact hours will be postponed until the February 2018 Board  
139 Meeting.
